JUNE HIKES

June 3 – Cherry Creek Ridge (Loop), 8:30 at WG (see **NOTES**). NW of New Castle on West Elk Creek. Moderate, wooded 8-mile loop. Last time we did this hike, we encountered a young, roan-colored “black” bear.

June 10 – Colorado Midland Railroad (Jerome Park), 9:00 at RF. W of Carbondale at Marion Gulch. Short climb leads to RR grade (easy hiking). Hike south or north ~3

miles along the grade and return.

June 12 – Battlement Reservoirs/Doghead Mountain, 7:30 at WG. South of Parachute on Battlement Mesa. Moderate 3.5-mi hike to lakes or more difficult 4.5-mi hike to peak.

June 17 – Three Forks, 7:30 at WG. N of Rifle Mountain State Park, wooded trail follows Three Forks Creek 5.5 miles to Bar HL Park.

June 24 – Sunlight Mountain Resort, 7:30 at RF (8:00 at Sunlight). A 6-mi loop climbs Grizzly Road and returns via the Ute Trail. Lunch at the ski patrol hut.

June 26 – Gore Creek/Lake, 7:00 at NN. East of Vail, trail follows Gore Creek east 4 miles (1700’ gain), then climbs 1000’ more in 1.5 mi north to Gore Lake. Alternative destination: Red Buffalo Pass (6.5 mi, 3200’ gain).

NOTES: WG refers to the West Glenwood Park & Ride on Wulfsohn Rd. W of Lowes. Until further notice, we will be using this P&R as our rendezvous in lieu of West Mall.

Due to our unusually high snowpack last winter, we may encounter deep snow at higher elevations well into July. Expect some changes to the schedule as required.

Those of us south of the Midland Ave. roundabout allow extra travel time for construction delays on S Midland and 27th Street Bridge.
