While masks are no longer required outdoors at Aspen resorts, masks are required in all gondolas and all indoor venues, and proof of vaccination also is required at certain indoor venues: Cloud Nine (including the deck), Alpin Room at High Alpine, Lynn Britt Cabin and Sam's Smokehouse Restaurant.

Sunlight will adhere to Garfield County public health restrictions due to COVID. We will resume our regular Wednesday schedule there next month. Don't forget to pick up your 2021-22 pass. A new photo will be taken (no carry-over from last year).
